## ELIGIBILITY

An applicant must meet the following qualifications:

- A. Must attend Kansas City Kansas Community College School of Mortuary Science.
- B. Desire to pursue a career in mortuary science.
- C. Be a resident of Nebraska.
- D. Meet all pre-mortuary academic requirements of the State of Nebraska prior to entering mortuary science college.
- E. The scholarship application must be mailed to the committee and the personal interview conducted prior to entering Kansas City Kansas Community College School of Mortuary Science.
- F. Be of good moral character.
- G. A letter of recommendation from a member of the Nebraska Funeral Directors Association must accompany each application.
- H. Submit written application, high school and college transcripts, and a letter from the credentialing division of the State of Nebraska showing that all pre-mortuary science requirements have been met. Applications must be submitted to the Nebraska Funeral Directors Association office by June 30<sup>th</sup> of each year.
- I. Must return to Nebraska after graduation from mortuary school for a period of no less than 3 years. If the applicant leaves the state of Nebraska before the 3-year period is up, the total sum received from the scholarship will be refunded directly to the Swanson Scholarship Fund.

## METHOD OF SELECTION

- A. Personal interview by at least three current members of the Nebraska Funeral Directors Association Laughlin Trust Committee.
- B. Applicant must appear in person before the committee no exceptions.
- C. Selection to be made by the Laughlin Trust Committee by July 31<sup>st</sup> of each year.

## ALLOCATION OF FUNDS

- A. Normally scholarships will be given for all 3 semesters at KCKSCC.
- B. Scholarship grant will cover tuition and books.
- C. Grants awarded will be based on funds available and the decision of the Committee.
- D. All grants will be paid directly to KCKSCC School of Mortuary Science rather than to the individual recipient.
- E. If for any reason a recipient of such a scholarship grant should drop out of school, that portion of Trust grant money not used is to be returned directly to the Trust and not refunded to the recipient for their personal use.
